Catalog Course Description

Origin, development, philosophy and constitutional basis of evidence, constitutional and procedural considerations affecting arrest, search and seizure; kinds and degrees of evidence and rules governing admissibility; judicial decisions interpreting individual rights and case studies. 54 lecture hours.

Course Objectives

- provide a working knowledge of the rules of evidence, the various kinds of evidence, and the admissibility of evidence
- develop the ability to evaluate the various kinds of evidence available in a given case in order to determine its admissibility in court
- develop the skills needed in handling case material so that evidence admissibility will not be destroyed by improper techniques or procedures
- explain the value of all kinds of evidence and the need to use proper procedures and techniques so as to maintain the value and admissibility of evidence
