The Business Mathematics course introduces students to understanding the ways of managing the finances of a business and in one's own personal life, including budgeting and money management, banking and credit, saving and investing. This class provides valuable information on how to use math in everyday business and personal finance. It teaches how to manage one's financial resources effectively for financial security. Students are taught the fundamentals of savings, payroll, taxes, problem solving, and innovation through the use of applied mathematics. 36 lecture hours.

- · Calculate decimals and fractions as percentages.
- · Adjust business equations, ratios, forecasting, and formulas.
- Comprehend electronic banking, checking accounts, check registers, checking services, and credit-card transactions.
- Calculate gross earnings: wages, salaries, piecework, and commissions.
- · Learn Social Security, Medicare, and other taxes.
- · Process invoice and cash discounts: ordinary dating methods.
- Understand markdown, turnover, and valuation of inventory. $\$
- Study basics of simple interest and find principal, rate, and time.
- · Calculate markup on cost and selling price.
- Cipher compound interest and interest-bearing bank accounts and inflation.
- · Determine annuities and retirement accounts.
- · Understand stocks, mutual funds, and bonds.
- · Tally property taxes, life and homeowners insurance.
