Catalog Course Description

Clinical application of theoretical concepts of medical-surgical nursing of clients with alterations of respiration, circulation, blood and immune system, endocrine, special senses, neurological and genitourinary conditions. Offered for Pass/No Pass grading only. 378 lab hours.

Course Objectives

- Perform beginning level assessment of clients with disorders affecting the abovementioned systems.
- Administer medications ordered by the physician following the seven rights of medication administration.
- Implement care of clients who require basic and advanced nursing care in a clinical setting.
- Evaluate care with health care team members and add to the plan of care.
- Document basic and advanced nursing care in the style appropriate to a clinical facility, using acceptable terminology.
- Demonstrate knowledge of critical thinking by presenting client's case at post conference and correlating all aspects of treatment and care.

 - a. Data gathering

 - i. nasopharyngeal suctioning
 - ii. tracheostomy care/suctioning
 - iii. care of chest tubes
 - iv. post-bronchoscopy care
 - v. thoracentesis
 - vi. postural drainage
 - vii. oxygen therapy
 - viii. pulse oximetry
 - ix. CPAP/ BiPAP machines
 - x. sputum collection
 - xi. breathing techniques
 - xii. incentive spirometry
 - xiii. rib belt application
 - c. Medication administration
 - d. Nursing care of clients with respiratory disorders
2. Care of the Client with Cardiovascular Disorders:
 - a. Data gathering
 - b. Performing/observing/assisting with the following procedures:
 - i. orthostatic blood pressure measurement
 - ii. attachment of ECG/telemetry needs with supervision
 - iii. nonstress test
 - c. Medication administration
 - d. Nursing care of clients with cardiovascular disorders
3. Care of the Client with Hematopoietic/Lymphatic/Immune Disorders:
 - a. Date gathering
 - b. Performing/observing/assisting with the following procedures:
 - i. bone marrow biopsy
 - ii. collection of blood for lab tests
 - iii. allergy testing
 - iv. blood transfusions
 - v. immunizations
 - vi. measuring output from drains (Jackson-pratt, hemovac)

 - vi. feeding
 - vii. seizure precautions
 - viii. logrolling technique
 - ix. application of traction
 - c. Medication administration

5. Care of the Client with an Endocrine Disorder:
 - a. Data gathering
 - b. Performing/observing/assisting with the following procedures:
 - i. Fingerstick glucose checks
 - ii. instituting hypoglycemia protocol
 - c. Medication administration
 - d. Nursing care of client
6. Care of the Client with a Genito-urinary or Renal Disorder:
 - a. Data gathering
 - b. Performing/observing/assisting with the following procedures:
 - i. peritoneal dialysis
 - ii. urine specimen collection
 - iii. urinalysis (ER)
 - iv. filtering urine for calculi
 - v. measuring hourly urinary output
 - vi. measuring output from urinary diversion collection devices
 - c. Medication administration
